The \$2,395 balance of the program fee and \$835 tuition for non-Hofstra students is due no later than February 1, 2013 and will be billed directly to you. Accepted students who cancel participation on or before January 25, 2013, will not receive the registration fee of \$300 refunded, but are not required to pay the balance of the program fee or tuition. Student who cancel participation after the January 25, 2013 deadline are required to pay the full program balance and tuition, if applicable. If you apply for financial aid but do not receive the aid by the deadline, Hofstra will accept a letter from your school stating that you will receive financial aid for the program.
