Purpose

Eligibility

All applicants must:

- 2. Be members of either the APALSA or SALSA student organizations;
- 3. Demonstrate financial need:
- 4. Possess a minimum cumulative GPA of 3.o.

To apply for the scholarship, please submit:

- 1. A completed and signed APALSA/SALSA Alumni Endowed Scholarship application;
- 2. A copy of your resume;
- 3. Letter(s) of recommendation (optional);
- 4. A personal statement (please see application for details); and
- 5. A copy of your most recent law school transcript.

Deadline

All documents should be submitted in a sealed envelope to the Office of Financial Aid, no later than 5 p.m. on March 17, 2014.

Submissions will be review by the APALSA/SALSA Alumni Scholarship Committee which will include Hofstra Law APALSA/SALSA alumni and members of the Law School's administration. The committee will recommend the final candidate(s) to the Dean of the Law School, who maintains final authority regarding the final award recipient(s).
