

To qualify for the scholarship, candidates must meet the following criteria:

- 1) The applicant must be a woman.
- 2) The applicant must be a resident of Nassau County.
- 3) The applicant must have been accepted to or currently enrolled in an accredited law school in Nassau, Suffolk, Queens, Brooklyn, Manhattan, Staten Island, Westchester, or Bronx Counties.
- 4) The applicant must have graduated college with a GPA of at least 3.0.
- 5) The applicant must maintain a GPA of at least 2.75 while enrolled in Law School for the year the funds are applied to.
- 6) The applicant should display characteristics consistent with the mission of the Nassau County Women's Bar Association.
- 7) The applicant must display financial need.

The postmark deadline for applications is April 16, 2015. Applicants may be asked to appear for an interview.
