ALSO NOTED

Eric Freedman's book on habeas corpus was reviewed in the February 1 edition of the *New York Law Journal*.

Leon Friedman successfully represented U.S. Civil Rights Commissioner Victoria Wilson before a federal district court in a dispute with the Bush Administration regarding the length of her term after a vacancy appointment. Leon's role in the case has been widely reported in such

publications as the *New York Times* and *Washington Post*. Leon also served as a principal author of a report of the Association of the Bar of the City of New York on reversing recent civil rights decisions of the U.S. Supreme Court.

Mitchell Gans served on the Suozzi transition team for county executive, evaluating the deficiencies and making recommendations regarding the tax certiorari bureau of the Nassau County Attorney's office.

Eric Lane has been named special counsel to the speaker of the New York City Council. The appointment was reported in the February 7 edition of the *New York Times*.
