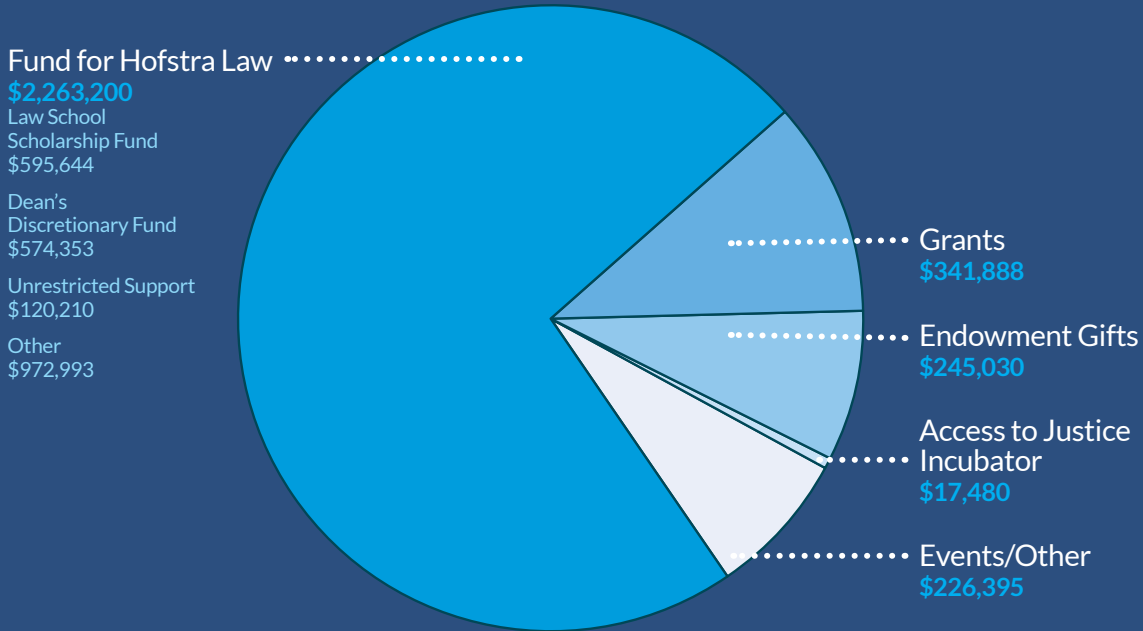

2016-2017 Financial Report

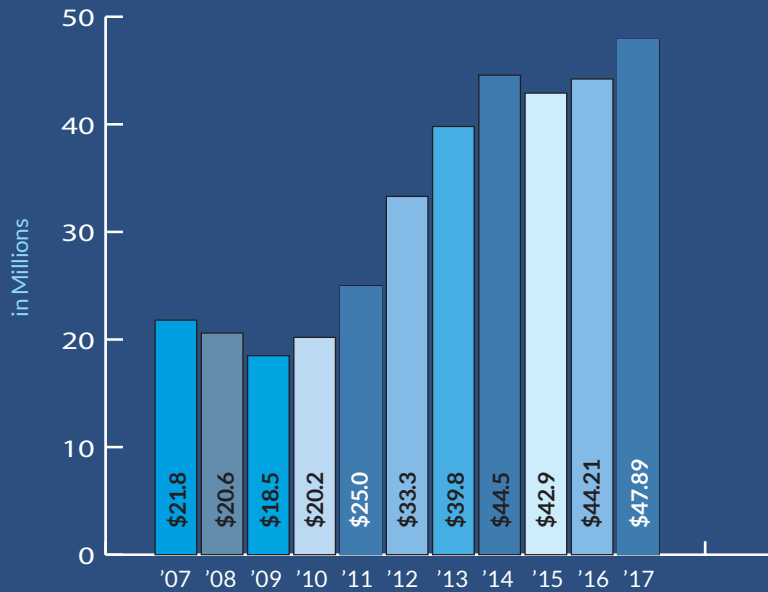
Support for the Maurice A. Deane School of law at Hofstra University continued to grow in 2016-17. Gifts and Grants received totaled \$3,093,993
