# LAND USE REGULATION (#3898)

### Adjunct Professor Brad Schwartz – Fall 2024

### CLASS SYLLABUS

#### **Course Description**:

This interdisciplinary course covers a variety of topics relating to the land development process in New York. It ties together: zoning, land use and real property law; the New York State Environmental Quality Review Act ("SEQRA"); administrative law; constitutional law; public policy; finance; community relations; and environmental science. We will use actual projects in communities on Long Island and in Westchester as case studies to apply these principles to practical, everyday considerations in the land use process.

### Learning Objectives:

- Fundamentals of land use/zoning regulation, including familiarity with State statutes (such as SEQRA and EDPL) and local codes
- Roles and responsibilities of different governmental agencies
- Approvals that are required for land development projects, such as rezonings, site plans, subdivisions, wetlands permits, and more
- Conducting the entitlement process before governmental agencies, including the roles of the lawyer, client, professional consultants, municipal officials, and the public
- Land use & SEQRA litigation
- Environmental considerations
- Eminent domain
- Current trends in land development

In addition, as set forth in the Law School's Learning Outcomes Policy, students will develop reasonable competency in the following:

- 1. Knowledge and understanding of substantive and procedural law.
- 2. Legal analysis and reasoning, legal research, problem-solving, and written and oral communication in the legal context.
- 3. Exercise of proper professional and ethical responsibilities to clients and the legal system.

### Expected Student Workload/ Hours of Work per Week:

The American Bar Association requires that you spend at least four (4) hours per week, on average, outside of class studying for this 2-credit course. Students will also be expected to

observe a land use board meeting (by Zoom). As described below, there will be two written assignments during the semester, plus the final exam.
